We offer courses for three different employee groups: Flight Crew and Load Planners, Ground Handling Staff, and Loading Staff

For Part 135, Part 125, and Part 91 initial and recurrent Hazmat training, our Hazardous Materials courses provide an understanding of the responsibilities of the operator and ground handling staff, freight forwarding staff, shippers and packers, and security team in the safe carriage of hazardous materials. Each of our Hazmat courses aligns with the training requirements for each job function specified in Part 121, Appendix O.
